### Urgent food solidarity measures

#### What this refers to

Families who are in a serious state of economic need due to the COVID 19 emergency can access grants to purchase those goods defined as basic necessities.

The contribution is granted only one time and will be paid in relation to the number of family members

#### What are the basic necessities

medicine, food products, personal hygiene - including nappies, diapers, sanitary napkins - and products for home hygiene; alcohol is excluded.

#### Who can access this contribution

1. subjects identified by the social services

2. resident citizens whose family unit no longer has sufficient income for sustenance and who possess at least one of the following requirements:

- loss of a job as a consequence of the emergency;
- Redundancy fund or similar, unemployed even if with NASPI, with other family members who have had a sharp reduction in income;
- VAT numbers and small entrepreneurs, professionals who have had a drastic reduction in turnover;
- intermittent and seasonal jobs that have had a drastic reduction in calls;
- case of serious illness or death of a family member linked to the COVID emergency that has just occurred which has led to a significant reduction in family income.

Applicants must also declare that they have:

- an availability of movable assets (extract of bank accounts but also securities and pass books) on March 28, 2020 as a total sum for all members of the household less than:
  - 5,000.00 Euros for 1 or 2 people
  - 7,500.00 Euros for 3 or 4 people
  - 10,000.00 Euros over 5 people

The following are excluded from the shopping voucher:

- the nuclei in which at least one of the components has an adequate estimated income to sustain the nucleus;
- recipients of forms of public support for a monthly amount exceeding:
  - 500 euros / month for 1-2 people;
  - 700 euros / month for 3-4 people;
  - 850 over 5 people

### **How can I access the contribution?**

Download the self-certification model from the website of the Municipality where you are resident, indicating the shops where you will shop (attaching the copy of a document) and send it as indicated in the form.

If you are already followed by the Social Services or if you want to be followed by the Social Services, please contact the office of the municipality where you are resident.

### **How will my request be answered?**

The questions will be evaluated weekly and will be answered by mail or phone.

### **Where can I go shopping?**

A list of all the shops participating in the initiative is published on the Municipality website. The shopping can be done at the stores indicated in the self-certification model.

### **Is there a deadline for applying?**

No, there is currently no deadline for applying. You have 60 days to shop once you have been allowed access to the contribution.
